

# THE 1990 INSTITUTE RELEASE FORMS New Asian American Voices

Obtaining proper written permissions is the responsibility of the parent or legal guardian of the contestant ("Producer").

The four most common release forms used in video and documentary productions are:

### **Appearance Release**

for those age 18 years and over appearing in photographs or videos

#### Minor Appearance Release

for children (any one under the age of 18), the appearance release must be signed by a parent or legal guardian

#### **Materials Release**

for obtaining permission from the owner or license holder to use photographs, audio, video, or other media that may be copyrighted or owned by others

#### **Location Release**

for use when you are videoing on private property you do not own

If you're working with professional actors and personalities, you'll probably need a special actor/model release form. Or they may give you a release form.

For locations, it's important to know who actually owns the non-public building or land you want to video on and also to find out who the current occupier is. For example, if you are videoing in a rented house you should get permission from the landlord as well as the tenant who is renting the property.
